

**TOWN OF BOGUE  
PLANNING BOARD MEETING  
February 1, 2018**

The Town of Bogue Planning Board met February 1, 2018 at the Bogue Town Hall, 121 Chimney Branch Road in Bogue. Co-Chair John Goguen called the meeting to order at 6:31pm. Roll Call was taken by the Clerk with the following members present: John Goguen, Bobby O'Chat, Scott Leahy, and alternate Rick Dougherty. Excused absent: Michael Panzarella and Shirley Page. Unexcused absent: alternate Richard Franklin. Also present was Clerk Elizabeth Sweeney and Attorney Donna Boggs.
