## **DECLARATION OF A STATE OF EMERGENCY**

WHEREAS, Hurricane Florence has the potential to impact the town of Bogue; and

WHEREAS, as a result of the above-described disaster, the Town Council has determined that there is an imminent threat of, or existing conditions have caused or will cause, widespread or severe damage, or significant impacts to transportation; and

**WHEREAS,** Carteret County Department of Emergency Services made a Declaration of Emergency on September 9<sup>th</sup> at 3:00pm for the same reasons.

**NOW, THEREFORE**, pursuant to the authority vested in the Town Council of Bogue under Article 1A of Chapter 166A of the North Carolina General Statutes:

**Section 1-** A State of Emergency is hereby declared within the jurisdiction of the town of Bogue.

**Section 2-** I hereby order all town employees and all other emergency management personnel subject to our control to cooperate in the enforcement and implementation of the provisions of this Declaration, all applicable local ordinances, state and federal laws.

**Section 3-** I hereby order this declaration: (a) to be distributed to the news media and other organizations calculated to bring its contents to the attention of the general public; (b) to be filed with Clerk to the Town Council and (c) to be distributed to others as necessary to ensure proper implementation of this declaration.

**Section 4-** This declaration shall take effect on September 10, 2018 at 8:00PM and shall remain in effect until modified or rescinded.

**DECLARED** this the <u>10<sup>th</sup> of September 2018</u> at <u>5:00PM</u>.
