Clerk Southard stated that Bogue RV asked what the Town rules are for outdoor lighting, specifically poles along Highway 24 with lights on them. Ethan Brogden stated that the military prefer lights facing down and with shields. They do not have any set rules for outdoor lighting for local communities. Bobby O'Chat stated that the shielded lights help project the lights downward and not spill out to adjacent properties. Cecil Hurst stated that the new storage facility on Highway 24 has outdoor lights. Donna Boggs asked about the Dark Sky Ordinance that the town looked into before. Bobby O'Chat said there was a grant and Ethan Brogden agreed, but that the project was stopped and nothing is in the works now. Bobby O'Chat stated that outdoor lights were not submitted with the original plan. Chris Griffin stated that you don't know what you will need until you are in the business/building and that you need lights with people coming at night for safety. Bobby O'Chat stated that we don't have enough information to either recommend or not recommend to the Town Council whether to approve the outdoor lights or not. Donna Boggs stated that it might be a good idea at a future planning board meeting to talk about getting an outdoor lighting ordinance together.
