The Town Council of Bogue met on Monday, December 15, 2025, at the Bogue Town Hall, 121 Chimney Branch Road.

Mayor Robert O'Chat called the meeting to order at 6:00 p.m. After the Pledge of Allegiance, Mayor O'Chat led a prayer.

Town Clerk Owens took roll call; all the Council Members were present.
